Sitting down and **reading the law is different from reading a novel or a textbook because the law has its own language**, but how you go about **understanding and learning the language of the law and law books** is the same as reading any other book, just as **this library is like any other library**.

When you're reading a novel and **don't know what a word means**, what do you do?

Look it up in a **dictionary**, of course.

And when you **don't know where a book is** in other libraries, where do you turn?

Yes, the **catalog**.

Let's go there, but, on the way, jot down some of the titles of **books that you pass**.



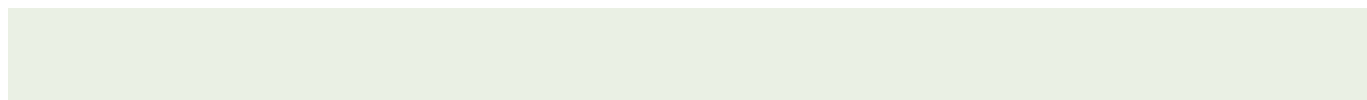

**We don't expect you to know what you're looking for** in these multi-volume texts and, that's actually a good thing. Sometimes we librarians wish that we could start over again at your age and relearn how to see and think about the law.

You're **looking at the law with fresh eyes**, so let's literally **browse through the law**. But **how?**

Look **on the spine of the books on the shelf** you're standing in front of now. What do you see?



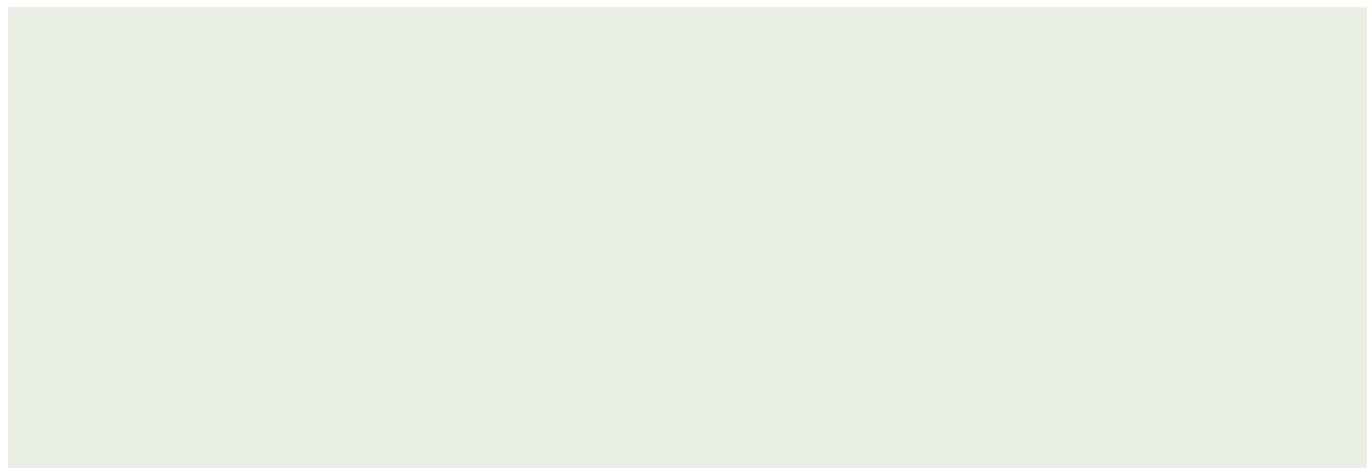
Those words on the spine of the book tell you exactly what is in that volume. **Those words are your access points to the law.**

Okay, but **you still don't know what those words mean, right?** Well, go ahead and open up a volume that says "index" and **turn to the back of the book.**

Pick a subject and **turn to the first page where that subject is discussed.** You'll find that just about **every entry's first section is titled "definitions" or "generally."**

Take the volume in your hand, and the legal dictionary you found earlier, back to the reading room and let's start unpacking the first few sentences below.

**What do you think your chosen topic covers?**

Now that you have a better understanding of your topic, how would you go about finding **more books** on this specific topic? (If you've decided that you're no longer interested in this topic, feel free to choose something else that does, **there's plenty to choose from**, after all.)

If you're **still unsure** about what you're reading, or where to go in the library's stacks, **don't be discouraged**, the librarians are always **happy to help you out**. In fact, we have a rule in the **Brooklyn Supreme Court Law Library** we call **The 10 Minute Rule**.

### **If You Can't Find What You're Looking for After 10 Minutes of Research Ask the Librarian!**

The **law librarians have years of experience behind them** and are the best resource the library has, so **please do disturb the librarian**.

This was just a **small introduction to the Brooklyn Supreme Court Law Library** to get you familiar with the collection and **pique your curiosity about the law** and legal research in New York.

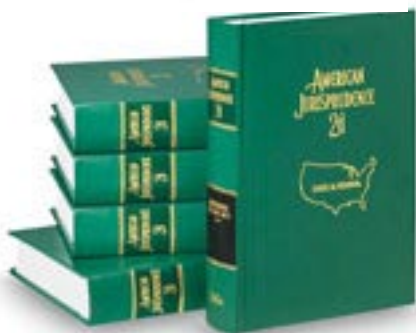
### Book Hunt!

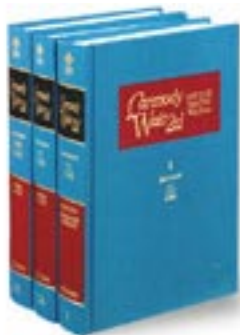
Go find the following books on the shelves and take notes on what they're about. You just might find something that you're interested in studying.

What **keywords**, in which books, catch your eye? Are there other books on those subjects?

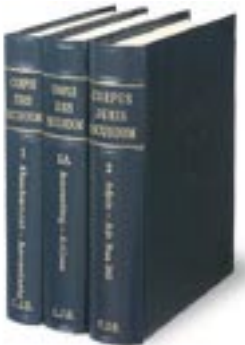
**How are these books organized?** Does every book have a table of content? An index?

Does **where the books are on the shelves** matter, or make sense, to you?

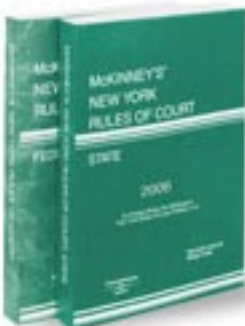

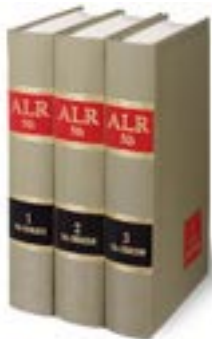

Many of the **book titles** on this hunt **have numbers after them**. What do they mean?

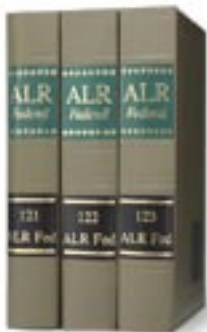
Some books look the same. **What is the difference between a state and a federal book?**

**Why do you think the library chose the specific books?**

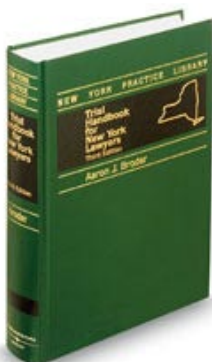
Which books **would you look at again?** Which ones might you pass over?

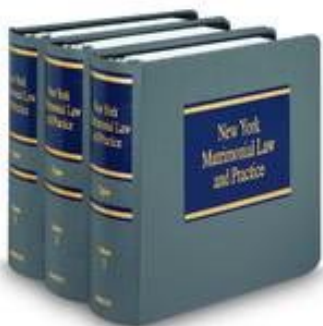

Are there **multiple copies** of any of the books? Which? **Why do think that is?**

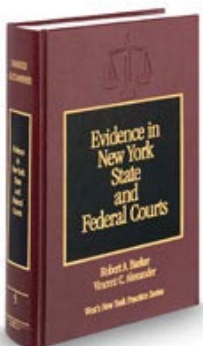

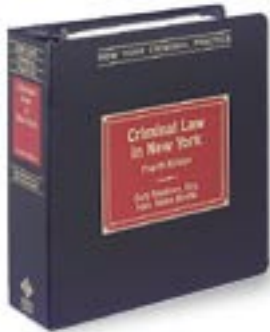
